The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

**ARTICLE ONE
NAME**

The name of the corporation is Home Help Desk, Inc.

**ARTICLE TWO
CORPORATE DURATION**

The duration if the corporation is perpetual.

**ARTICLE THREE
PURPOSE OR PURPOSES**

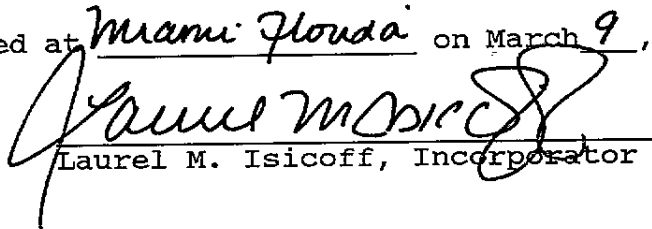
