The undersigned, whose names are affixed hereto as incorporators, do hereby associate together for the purpose of forming a corporation not for profit under the laws of the state of Florida, pursuant to Florida statutes, chapter 607, and do hereby adopt the following articles of incorporation for such corporation.

ARTICLE 1

NAME:

The name of this corporation, which is a organism of the " BODY OF CHRIST" shall be called "KINGDOM MINISTRIES, INC."

ARTICLE 11

ADDRESS

The initial address of the principal office of the corporation in the state of Florida is : 11517 Birch Forest Cir. E. Jacksonville Florida 32218.

The Board of Directors may from time to time move the principle office to any other address in the State of Florida.

ARTICLE 111

PURPOSE, POWER & NATURE OF BUSINESS:

The general, purpose, power and nature of KINGDOM MINISTRIES by the help of GOD is:

A. is to establish an organization to meet the spiritual, emotional and physical needs of nursing home residents throughout the state of Florida, and help develop a Christ like character, which is to love one another.

B. Create an increasing meaningful fellowship with GOD the FATHER.

C. Be a dynamic spiritual force which would share the love of God throughout the community, city, state and the world.

D. Promote love and unity throughout the "body of Christ."

E. Be a worshipping, fellowship, experiencing an awareness of GOD, recognizing his person, and responding in obedience to his leadership.

F. Authorize to consecrate Bishop, ordain Elders and Deacons, licence Ministers and appoint Pastors divinely called and qualified.

G. Organize, maintain, finance, operate and conduct such ministries as may be proper to the above mentioned purpose.

H. Own , control , lease and purchase and to take by gift,devise and bequest, or otherwise, and to convey, dispose of, mortgage, encumber , lease and in every respect to do all things and exerise all powers which a natural person might do and exerise over and about real or personal property of every nature and kind whatsoever, including real estate, lease holds bonds, stocks and securities where ever the same may be situated or located.

I. Maintain officers, headquarters, buildings or other facilities for accomplishing the object of this corporation.

J. To insure bonds, promissory notes, securities and agreements for or evidence of indebtedness of every character, and to mortgage, pledge or otherwise encumber property, to contract in or about properties, monies funds or other subject or matters of every character and kinds whatsoever.

K. Do everything else which a natural person could do incident to , necessary to, or convenient in connection with the objects of the incorporation, to sue and be sued in it's corporate name.
