

### Dear Mr. Spitler:

Enclosed please find your letter dated March 1, 1999 directed to our attention. In your letter, you state that Sweetwater Villas cannot be merged into Whitestone, as Sweetwater Villas was an administratively dissolved corporation due to its failure to file its 1998 corporate annual report form. Please find enclosed a copy of the 1998 Non Profit Corporation Annual Report Form as completed. Also please find enclosed a check drawn on the account of Sweetwater Villas Property Owners Association, Inc., payable to the Florida Department of State, Annual Reports Section, in the amount of \$61.25, which payment was deposited on April 22, 1998.

We note that on the Non Profit Corporation Annual Report Form the corporate name is incorrectly stated as Sweetwater Property Owners Association, Inc. The correct corporate name is Sweetwater Villas Property Owners Association, Inc. The FEI number is properly stated on the Annual Report as 65-0573964.

The Internet site for the Florida Division of Corporations reveals that there exists a Sweetwater Property Owners Association, Inc., and that its information has been changed as per the enclosed annual corporate form. However, the FEI number for Sweetwater Property Owners Association, Inc. is different than the FEI number on the enclosed Annual Report Form of Sweetwater Villas.

We are requesting the Secretary of State, Division of Corporations correct this error. The \$61.25 filing fee for FEI number 65-0573964 was paid for Sweetwater Villas Property Owners Association, Inc. The balance of the information on this form is correct.

Unless you need further confirmation from the Association, please proceed to merge Sweetwater Villas Property Owners Association, Inc. into Whitestone Property Owners Association, Inc.
