**ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
SORRENTO VILLAS, SECTION 6, CONDOMINIUM
ASSOCIATION, INC.**

KNOW ALL MEN BY THESE PRESENTS:

The Unit Owners/Members of SORRENTO VILLAS, SECTION 6, CONDOMINIUM ASSOCIATION, INC., a Florida not-for-profit corporation organized under Chapters 617 and 718 of the Florida Statutes, and being the entity responsible for the operation of SORRENTO VILLAS, SECTION 6, CONDOMINIUM, situated in Nokomis, Sarasota County, Florida, in accordance with the Declaration of Condominium recorded in Official Records Book 1028, Page 1395, et seq., of the Public Records of Sarasota County, Florida, have adopted an amendment to the Articles of Incorporation as described hereinbelow:

ARTICLE 3, ENTITLED "POWERS", at Section 3.2 thereof, "SPECIFIC POWERS", at Subsection (f) thereof, is hereby amended as follows:

- (f) To make and amend reasonable regulations respecting the use of the property in the condominium; provided, however, that all such regulations and amendments thereto shall be approved by not less than 75% of the votes of the entire membership of the Association a majority of the entire Board of Directors before the same shall become effective.

KEY: Words underlined are additions to the existing Articles of Incorporation.
Words in shading are deletions from the existing Articles of Incorporation.


The foregoing amendment was adopted by the members at the annual meeting of the Corporation on February 11, 1999, at which meeting a quorum was present, and the amendment was approved by a sufficient number of votes cast by the members, being 31 in favor, none opposed and six abstentions; said meeting having been called, in part, for the purpose of considering the foregoing amendment to the Articles of Incorporation.

Such action was taken subsequent to a meeting of the Board of Directors, who, by a unanimous vote, adopted a similar resolution in support of the foregoing amendment.
