### ARTICLES OF AMENDMENT TO THE **ARTICLES OF INCORPORATION OF** POSES & HALPERN, P.A., a Florida professional corporation

Pursuant to Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, POSES & HALPERN, P.A., a Florida professional corporation (the "Corporation"), hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- The name of the Corporation Is: POSES & HALPERN, P.A. 1.
- 2. The following is the amendment to the Articles of Incorporation, which has been adopted by the Board of Directors and Shareholders of the Corporation. Articles I and II of the Articles of Incorporation of the Corporation are amended in their entirety to read as follows:
