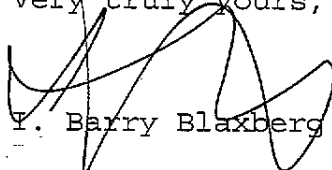

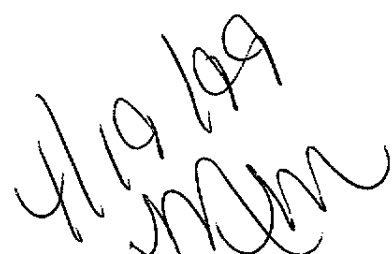

ARTICLES OF INCORPORATION OF
EURO PROCUREMENT GROUP, INC.

ARTICLE I.
CORPORATE NAME

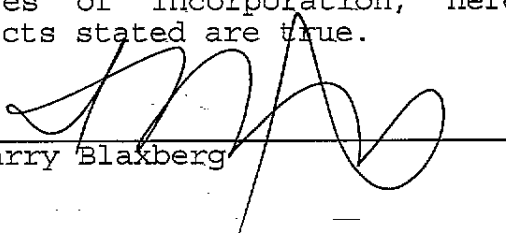

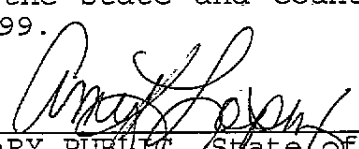

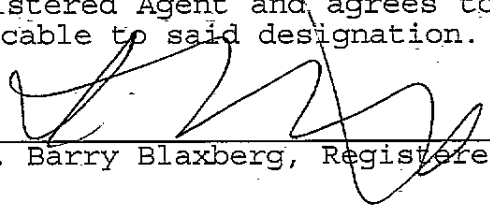
