ARTICLES OF INCORPORATION OF

MCDONALD'S AT TAVERNIER TOWNE, INC.

The undersigned desiring to incorporate under the laws of the State of Florida does hereby make, publish, and declare these Articles of Incorporation.

ARTICLE I

The name of this corporation shall be

McDonald's at Tavernier Towne, Inc.

ARTICLE II

This corporation shall exist perpetually until dissolved.

ARTICLE III

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV

This corporation is authorized to issue TWO THOUSAND (2,000) shares of common stock with \$1.00 par value. The Corporation is authorized to issue no more than 1,000 voting common shares, and 1,000 nonvoting common shares. The voting common shares shall be designated "Series A Voting Common Shares," and the nonvoting common shares shall be designated "Series B Nonvoting Common Shares."

ARTICLE V

The name of the initial registered agent and street address of the initial registered office of this corporation is:

ARTICLE VI - PREEMPTIVE RIGHTS

Every shareholder, upon sale for cash of any new stock of this corporation of the same kind, class, or series as that which the shareholder already holds, shall have the right to purchase a pro-rata share (as nearly as may be done without issuance of fractional share) at the price at which it is offered to others.

ARTICLE VII

This corporation shall have one initial director. The number of directors may be increased or diminished from time to time as provided in the bylaws, but shall never be less than one. The name and address of the initial director of this corporation is:

No Shareholder shall transfer his or her shares of Stock to any person, firm, or corporation other than the Company, unless the Shareholder desiring to transfer shall first have made a written offer to sell the Stock to the Corporation on the same terms and conditions and such offer shall not have been accepted within 30 days of receipt of the offer. If the Corporation accepts the offer, the closing shall occur within 30 days.

The Corporation shall have the right of first refusal to purchase shares of Stock that are the subject of a bona fide offer. No shareholder shall transfer his or her shares of Stock to any person, firm or corporation without affording the Corporation the right to purchase the Stock on the same terms and conditions as that made by any bona fide offeror. The person desiring to

and provide the Corporation with a copy of the written offer. The Corporation shall have 30 days to exercise its right of first refusal to accept the offer. The closing shall occur within 30 days of the Corporation's acceptance of the offer on the same terms and conditions of the offer.

ARTICLE XII

The corporation may purchase life insurance on the lives of its key officers and directors, with the proceeds to be paid to the corporation and to the heirs and assigns of the insureds as the Board of Directors of the Corporation may deem appropriate.


