Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida for profit corporation adopts the following articles of amendment to its Articles of Incorporation:

**FIRST:** Amendments adopted:

(A) Article III of the Articles of Incorporation is hereby amended as follows:

**ARTICLE III - SHARES**

All stock issued by the Corporation shall be common voting stock of a single class. The maximum number of shares of stock which this corporation is authorized to have outstanding at any time is two-thousand five hundred (2,500) shares having a par value of one cent (\$.01) per share.

(B) Article VI is hereby added to the Articles of Incorporation as follows:

**ARTICLE VI - PREEMPTIVE RIGHTS**

The Corporation elects to have preemptive rights, pursuant to Section 607.0630, Florida Statutes, as amended from time to time.

(C) Article VII is hereby added to the Articles of Incorporation as follows:

**ARTICLE VII - BOARD OF DIRECTORS**

The business of the corporation shall be managed by its Board of Directors. The initial Board of Directors shall consist of two members whose names and addresses are as follows:
