The undersigned, for the purpose of forming a corporation under the Floridal Business Corporation Act, Florida Statutes §607.0101, et seq., hereby adopts the following Articles of Incorporation:

ARTICLE ONE

1.01 The name of this corporation is DIVOSTA CHILDREN TRUST HOLDINGS, INC.
