to

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted: (INDICATE ARTICLE NUMBER(S) BEING AMENDED, ADDED OR DELETED.)

In accordance with the requirement of Section 501(C)(3), the following amendment is approved this Fifteenth (15) day of June, nineteen hundred and ninety nine (1999), by the voting members of the El Sinai Church, Asamblea de Dios, Inc. and in accordance with Article VIII of the Charter of Incorporation and of the by-laws of this document, in regular business session, having received the required two thirds majority vote of all parties indicated therein. This action has been recorded in the minutes of said business session on the date indicated.

Article II, Sections "C" and "D" are being added hereby as follows:

- C. *The purpose for which the corporation is organized are exclusively religious, charitable and educational within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.*
- D. *Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law.*

Article V is being amended hereby as follows:

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Sections 501(C)(3) and 170(C)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State or local government for exclusive public purpose.


