Dear Ms. Harris:

I have been the REGISTERED AGENT of the corporation since we first incorporated, and we have always paid the ANNUAL REPORT long before it was due. This year we sent an EXTENSION REQUEST from IRS in Atlanta, for the first time, since we only did ONE JOB in 1998 and have only done ONE in 1999. When I mailed that EXTENSION REQUEST to IRS in Atlanta, I also mailed likewise one to Tallahassee. Then I received yesterday a "2nd Notice" from your office and I was in kind of a shock, so to speak!

I called the lady that does our ANNUAL CORPORATE TAX who is different from the lady who has been doing our accounting since we incorporated and this latter one is not doing it any more and the lady that does our ANNUAL CORPORATE TAX at H&R BLOCK PREMIUM (corporate tax) said that what I sent to Tallahassee is to REVENUE Dept. and NOT the annual report: LITTLE DID I KNOW!

We do not have ANY employees, no payroll since we only use the IRS FORM 1099 MISC since we only provide FREE-LANCE simultaneous conference interpreters and the United Nations-style WIRELESS, SIMULTANEOUS INTERPRETATION EQUIPMENT. WE DO NOT TRANSLATE. This is not a daily job for any such business as ours, nowhere in the world. Things have been going bad for us, my sister, Caridad Prieto, the President, and I, since 1997 and including 1998 and now. We are trying to raise the business and we are asking, please, for an abatement. In other words, that you do accept the \$150.00 enclosed supposed to have been there by May 1, 1999, and not the \$550.00 for late payment. My sister and I are both single, 75 and 70 years old respectively, and we don't have a family; we don't own real estate or bonds or anything, we rent. We do not have an office open to the public either, because we do not need to. Our check for \$150.00 is enclosed.

Enclosed is the fee for \$150.00 for the Supplemental Corporate Fee. We did not send it before May 1, 1999 because like now, we did not have it. We are both professionals and DO NOT WANT TO FILE BANKRUPTCY or much less have our CORPORATION dissolved in any way shape or form. Could you help us with an abatement? Please let us know as soon as possible. WE DO WANT TO GO ON with our BUSINESS and with our CORPORATION. We are home-based entrepreneurs.
