ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF
PENSACOLA FAMILY CARE FOR YOUTH, INC.

Article I of the Articles of Incorporation of Pensacola Family Care for Youth, Inc., is hereby amended to read:

ARTICLE I

NAME

The name of the corporation shall be "PENSACOLA FAMILY CARE FOR YOUTH AND FAMILY SERVICES, INC."
