## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PENSACOLA FAMILY CARE FOR YOUTH, INC.

Article I of the Articles of Incorporation of Pensacola Family Care for Youth, Inc., is hereby amended to read:

## ARTICLE I

#### NAME
