The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be WEST GULF DIGITAL, INC. The address of the principal office of this corporation shall be: 14 Josh's Way Landenberg, PA 19350 and the mailing address of the corporation shall be: 14 Josh's Way Landenberg, PA 19350.

ARTICLE II. NATURE OF BUSINESS
