### ARTICLES OF INCORPORATION FOR

#### FLORIDA RESOURCE CENTER FOR WOMEN AND CHILDREN, INC.

The undersigned, acting as incorporators of a corporation purusant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

#### ARTICLE I-NAME

The name of the corporation shall be: Florida Resource Center for Women and Children, Inc.

ARTICLE II- PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

2084 Radnor Road Juno Beach, FL 33408

#### ARTICLE III - PURPOSE

The specific purpose for which the corporation is organized is:

- A. The corporation is organized exclusively for those lawful purposes not for pecuniary profit for which a corporation may be formed under the laws of the State of Florida. This organization is organized and shall be operated exclusively for charitable purposes as a tax exempt entity under Section 501(c) 3 of the Internal Revenue Code of 1986, as amended and in accordance with Florida Statutes, Chapter 617, for the following purposes:
- B. To promote public education and communication of family issues on a statewide level.
- C. To support member organizations and individuals serving families, including technical assistance and advocacy.
- D. To serve as advocates for women and children.
- E. To provide support services to families that will empower them to self-sufficiency, independence and a productive quality of life.



#### ARTICLE IV - MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is as follows:

- A. The original members of this Corporation shall consist of the subscribers to these article. Thereafter, the members of this Corporation shall consist of those persons approved by the Board of Directors without any further qualification or restriction on membership.
- A. At the October meeting of the Board of Directors, the terms of 1/3 of the directors shall expire and their successors shall be elected by the remaining 2/3 of the directors for a term of 3 years.
- B. No member of the Board of Directors shall be eligible to serve more than 2 consecutive 3 year terms unless the Board of Director is serving as an officer of the corporation, in which event, he/she may be elected to one additional 1 year term.

#### ARTICLE V - LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

No substantial part of the activities of the corporation shall consist of carrying on the propaganda or otherwise attempting to influence legislation, except as provided by law. No part of the activities of the corporation shall be participating in or intervening in (including publication or distribution of statements,) any political campaign on behalf of any candidate for public office.
