Capital Stock

"The aggregate number of shares of stock authorized to be issued by this corporation shall

be 20,000,000 shares of common stock, each with a par value of \$.001 (the "Common Stock"),

and 5,000,000 shares of preferred stock, each with a par value of \$.01 (the "Preferred Stock").

permitted by law, as determined from time to time by the Board of Directors and stated in any

resolution providing for the issuance of such shares adopted by the Board of Directors pursuant

to authority hereby vested in it, each series to be appropriately designated, prior to the issuance

of any shares thereof, by some distinguishing letter, number or title.

Before any shares of a particular series of Preferred Stock are issued, the designations of

such series and its terms shall be fixed and determined by the Board of Directors in any manner

permitted by law and stated in a resolution providing for the issuance of such shares adopted by
