ARTICLES OF ORGANIZATION  
OF  
U-STOR RIDGE ROAD, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, adopts the following Articles of Organization:

1. Name and Address. The name of the Company shall be U-STOR RIDGE ROAD, LLC (the "Company.") The mailing address of the Company shall be 2712 Powell Lane, Tarpon Springs, Florida 34689, and the principal address is the same.

2. Duration. The Company shall have perpetual existence.

3. Purpose. The purpose of the Company is to engage in any activities of business permitted under the laws of the United States and of Florida.

4. Initial Registered Office and Agent. The name and address of the initial registered agent and office of the Company is JOHN BORK whose address is 2712 Powell Lane, Tarpon Springs, Florida 34689.

5. Capital Contributions. The members of the Company shall contribute to the capital of the Company the cash or property set forth in the Affidavit of Membership attached as Exhibit A.

6. Admission of New Members. 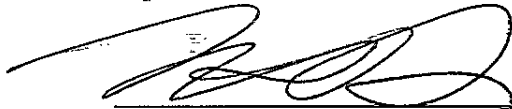
