ARTICLES OF INCORPORATION

OF

Incorporation

The undersigned, being the sole subscriber to these Articles of Incorporation is a natural person competent to contract, hereby undertaking to form a corporation under the laws of the State of Florida.

ARTICLE X. AMENDMENT


