FIRST:



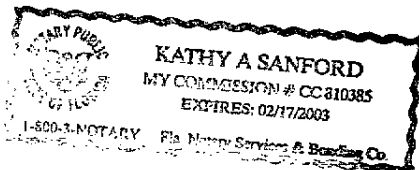
