#### ARTICLES OF INCORPORATION OF VALENCIA PLACE HOUSING ASSOCIATES, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

## Article I

The name of the corporation is VALENCIA PLACE HOUSING ASSOCIATES, INC.

#### <u>Article II</u> DURATION

  - (b) Preemptive Rights. Shareholders shall have no preemptive rights.

(c) Cumulative Voting, Cumulative voting shall not be permitted.

#### Article VII DIRECTORS
