ARTICLES OF INCORPORATION

SECHETARY OF STATE TALLAHASSEE, FLORIDA

OF

VALVERDE INVESTMENTS, INC.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Valverde Investments, Inc. and its address is 279 Galeon Court, Coral Gables, Florida 33143.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The general purpose for which the corporation is organized are:
