ARTICLE I

NAME

The name of this corporation shall be Kol DoDi, Inc.
14570 Military Trail, Suite C1, Delray Beach, FL 33484

ARTICLE II
INCORPORATOR

Articles of incorporation are executed by Ronald Baehr

ARTICLE III

Purpose

- (A) This congregation is organized as a church exclusively for charitable religious, and educational purposes within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986, including, but not limited to, for such purposes as the establishing and maintaining of religious worship; the building, maintaining, and operating of churches, parsonages, schools, chapels, radio stations, rescue missions, printshops, day-care centers(nurseries), camps, nursing homes, cemeteries, and any other ministry that the church may be led by God to establish, and to exercise all other powers conferred upon it by its character or by the applicable nonprofit corporation law of the state of Florida; and all in accordance with its Bylaws as the same may be hereinafter amended. The term of existence of the corporation is perpetual.

- (B) The church shall also ordain, license and/ or commission men to the Gospel ministry; evangelize the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; educate believers in manner consistent with the requirements of Holy Scripture, both in Sunday and weekly schools by means of Christian education; maintain missionary activities in the United States and any foreign country; and engage in any other ministry that the church may decide to pursue from time to time, in obedience to the will of God.

ARTICLE IV

DIRECTORS

The affairs of the corporation are to be managed by a board of directors consisting of President, Vice-President, Treasurer, and Secretary. The president shall serve as pastor of the church. There shall be no less than three (3) members of the board of directors. The number of directors shall at all times be equal to and composed of, the number, and individuals, ordained and serving as pastor and as elders.

ARTICLE VI MEMBERS

- 4) Be baptized in water by immersion.
- 5) Commit himself to participate actively in the fellowship of the church with a teachable attitude and complete all requirements and courses and policies set forth by Pastor and Board of Elders.
- 6) Support the Church with tithes and offerings.
- 7) Submit himself to the authority of the leaders and the discipline of the church.

These Articles of Incorporation may be amended only by the act of the Board of Directors of the Corporation. Such amendments may be proposed and adopted in the manner provided in the By – Laws of the Corporation.


ARTICLE IX


ARTICLE XI
