**ARTICLE I - NAME**

The name of this corporation shall be Second Chance for Greyhounds, Inc.

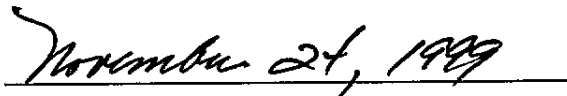
