**ARTICLES OF INCORPORATION OF  
CITIZENS FOR SANITY, PASCO COUNTY, INC.**

The undersigned incorporator, Clay Colson, hereby incorporates the Citizens for Sanity, Pasco County, Inc., as a Florida not-for-profit Corporation.

**ARTICLE I-NAME OF CORPORATION**

The name of the not-for-profit organization is the Citizens for Sanity, Pasco County, Inc.

**ARTICLE II-PRINCIPAL OFFICE**

The principal office of the Citizens for Sanity, Pasco County, Inc., is 3108 Land O' Lakes Boulevard, Land O' Lakes, Florida 34639.

**ARTICLE III-CORPORATION PURPOSES**

Citizens for Sanity, Pasco County, Inc. is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gains of any person. The specific purposes of this corporation are:

A.) To improve the quality of life and government throughout Pasco County by the exercise of all rights and powers conferred by the laws State of Florida upon non-profit organizations.

B.) To support the citizens of Pasco County by fostering and encouraging a spirit of cooperation through and with citizens groups, homeowner associations and civic associations to work for and ensure a better way of life.

**ARTICLE IV-ELECTION OF DIRECTORS**

The three initial directors of the Citizens for Sanity, Pasco County, Inc. during the first year of incorporation are appointed by the incorporator, Clay Colson. Each year thereafter the number of directors and the method of their election is as provided by the Bylaws.

**ARTICLE V-INCORPORATOR/REGISTERED AGENT**
