1. The name of the Corporation is currently SDS Systems, Inc
2. The date of the filing of the Articles of Incorporation was October 31, 1990.
3. The Articles of Incorporation are amended as follows:
  - a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the

following:
