The undersigned, all of whom are duly licensed to practice Real Estate sales in the State Of Florida, desiring to form a professional corporation in accordance with Chapter 621 of the Florida Statutes and the Professional Service Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE I. NAME**

The name of the corporation is **B. ACKERMAN, P.A.**

**ARTICLE II. DURATION**

The period of its duration is perpetual.
