ARTICLES OF ORGANIZATION OF

GASFORAL, L.L.C.ARTICLE I
NAME

The name of this Limited Liability Company shall be GASFORAL, L.L.C. (the "Company").

DURATION

ARTICLE VIII
NEW MEMBERS

No additional members shall be admitted to the Company, and no member may transfer his or her interest in the Company, except, in either case as set forth in the Regulations, and if there are no Regulations then in effect, by unanimous consent of all of the members. 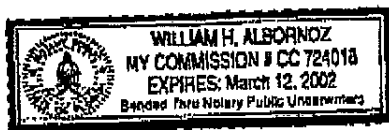

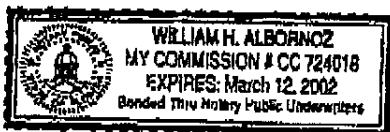

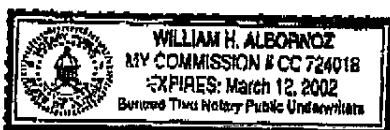
