The undersigned subscriber to these Articles Of Incorporation hereby subscribes to and forms a corporation for profit under the laws of the State of Florida.

ARTICLE I - NAME

The name of this Corporation is JERRY PYBUS ELECTRIC, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of business to be conducted by this Corporation shall be to do all things that now are or may hereafter be allowed to corporations by the laws of Florida even though the existing laws may hereafter be repealed.

ARTICLE III - DURATION

This Corporation shall have perpetual existence and shall commence on February 1, 2000.

ARTICLE IV - CAPITAL STOCK

The aggregate number of shares which this Corporation is authorized to issue is ten thousand shares of common stock. Such shares shall be of a single class and shall have a par value of \$10.00 per share. One thousand of said shares shall be designated as voting stock and the remaining nine thousand of said shares shall be designated as non-voting stock with said designation printed on the face of each share certificate indicating whether said certificate is for voting or non-voting stock.

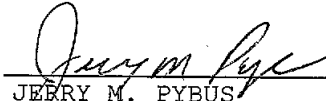
