

ARTICLES OF INCORPORATION

LEGACY HOMES OF NORTHEAST FLORIDA, INC.

The undersigned, for the purposes of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I

Name and Principal Office

Section 1.1. Name. The name of the corporation is LEGACY HOMES OF NORTHEAST FLORIDA, INC.

<u>Section 1.2.</u> <u>Principal Office and Mailing Address.</u> The principal office and mailing address of the corporation is located at 1914 Art Museum Drive, Jacksonville, Florida 32207.

<u>Article II</u>

Duration

Section 2.1. <u>Duration</u>. <u>This</u> corporation shall exist perpetually. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of Florida within five days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

Article III

Purposes

Section 3.1. Purposes. This corporation is organized for the purpose of transacting any or all lawful business permitted under the laws of the United States and of the State of Florida.

Article IV

Capital Stock

Section 4.1. Authorized Capital. The maximum number of shares of stock which this Corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having a par value of \$.01 per share.

- Section 4.2. Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this corporation as they may see fit.
- Section 4.3. Approval of Shareholders Required for Merger. The approval of a majority of the shareholders of this corporation to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.

Article V

Initial Registered Office and Agent

Section 5.1. Name and Address. The street address of the initial registered office of this corporation is 1914 Art Museum Drive, Jacksonville, Florida 32207, and the name of the initial registered agent of this corporation at that address is Edward D. Woodland.

Article VI

Directors

- Section 6.1. Number. This corporation shall have one (1) director/directors initially. The number of directors may be increased or diminished from time to time by the bylaws, but shall never be less than one.
