ARTICLES OF INCORPORATION
SOTELO FINANCIAL & TRADE CORP.

ARTICLE 1

The name of this Corporation shall be
SOTELO FINANCIAL & TRADE CORP.

ARTICLE II
PURPOSE

This Corporation may engage in the trasaction of any or all lawfull business for which corporations may be incorporated under the Florida General Corporation Act of the State of Florida.

ARTICLE III
CAPITAL STOCK

The maximum number of shares of stock that this Corporation is authorized to issue at any time is 1000 shares of \$10,00 per value each.

ARTICLE IV
PREEMPTIVE RIGHTS

The shareholders of this Corporation shall be have preemptive rights to acquire unissued or treasury shares of the Corporation, right to subscribe to or to acquire shares of the Corporation to the extent that the stockholders might so specifically set forth. Lacking this affirmative action by the Stockholders, there shall be no such preemptive rights.

TERM OF EXISTENCE

This Corporation is to have perpetual existence.

This Corporation shall at all the times have at least one and not more than 5 (five) Directors, who shall conduct the business of the Corporation as a Board of Directors. The By Laws of this Corporation may be created, amended, changed or replaced by the Stockholders of the Corporation at any duly scheduled Special Meeting called for that purpose.


ARTICLE XII


