**ARTICLES OF AMENDMENT
OF
ARTICLES OF INCORPORATION OF
FIRST QUALITY REHABILITATION CENTERS OF HOLLYWOOD, INC.**

1. The name of the Corporation is First Quality Rehabilitation Centers of Hollywood, Inc.

2. Article I of the Articles of Incorporation of the Corporation is hereby amended to read as follows:

"ARTICLE I

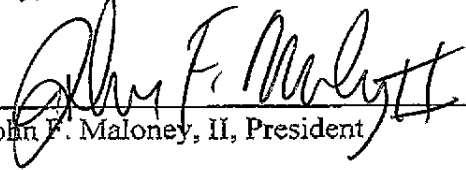
The name of this Corporation is:

3.
