
ARTICLE V

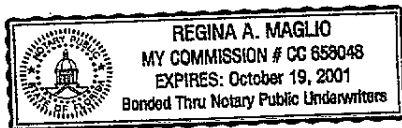
