**AMENDMENTS TO THE
ARTICLES OF INCORPORATION
OF
OAKCREST BAPTIST CHURCH, INC.
(A Corporation Not for Profit)**

We, the undersigned, with other persons being desirous of forming a corporation for charitable and philanthropic purposes, under the provisions of Chapter 617 of the Florida Statutes, applicable to corporations not for profit, do agree to the following:

ARTICLE I NAME (AMENDED)

The name of this corporation is changed to Cornerstone Baptist Church Of Pensacola, Inc. and its principle place of business and worship shall be 5454 Mobile Highway, Pensacola, Escambia County, State of Florida 32526.

ARTICLE VI. ADMISSION TO MEMBERSHIP (AMENDED)

The manner of admission to membership in said corporation shall be by letter of dismission from other churches of like faith and order and by satisfactory statement of former membership in a Missionary Baptist Church, and profession of faith as hereinabove provided in Article V, upon the unanimous vote of the membership of said corporation present at any meeting of said Church. The present membership of Cornerstone Baptist Church of Pensacola, Inc. and those hereafter admitted to membership shall constitute the membership of this corporation.

ARTICLE IX. BODY OF DEACONS (AMENDED)

- (1) The Deacons shall be in any number the church deems necessary. They shall be men who meet the New Testament qualifications of the King James Bible and shall be elected by the church to serve for as long as the church requires. The duties of a Deacon shall be those as set forth in the New Testament, and any others as set forth by the church..
- (2) Deacons shall be elected from and by the membership of said church corporation.
- (3) The Deacon body shall be elected according to the By-Laws of the church..
- (4) The Deacon body shall be elected to serve the church as long as the church deems necessary and according to the church By-Laws.
- (5) The said Deacon body shall have as many officers as they deem necessary to carry out the mission of serving the Lord's church..
- (6) The Deacon body along with the pastor shall sign and execute all legal documents for and on behalf of the church corporation.
- (7) The Chairman of the Deacon body along with the pastor shall set regular Deacon's meetings as are necessary to serve the needs of the church.
- (8) The present body of Deacons of Cornerstone Baptist Church, Inc. are as stated below and shall serve as long as the church sees fit.

ARTICLE X CORPORATION OFFICERS (AMENDED)

The President of the corporation is the Pastor (indefinite). The Trustees of the corporation are the Deacons with the Pastor (indefinite). The Church Clerk elected by the church each year. The Church Treasurer elected by the church each year. The church

shall elect as many officers of the corporation as they deem necessary at the first business meeting of the new physical year.

ARTICLE XI. BY-LAWS (AMENDED)

The members of the church shall have the right to make and adopt such By-Laws as they shall deem proper and advisable for the conduct of its business and the carrying out of its purpose. These By-Laws may be changed or amended by 60% vote of the church members present at any regular or called business meeting for that purpose.

ARTICLE XII AMENDMENTS (AMENDED)

These Articles of Incorporation may be amended by 60% vote of the church body present at any called meeting or regular business meeting announced for such purpose.
