ARTICLES OF INCORPORATION
OF
CARIBBEAN GLOBAL INTERNATIONAL, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Caribbean Global International, Inc.
