1. SECTION 14. AMENDMENT OF DECLARATION. Item 14.4, APPROVAL, is amended as follows:

"Except as elsewhere provided, the approval of a resolution for the adoption of a proposed amendment to this Declaration shall require the affirmative vote of two-thirds of the members of the Board of Directors of the Association, and the affirmative vote of ~~not less than seventy-five (75%) percent~~ a majority of the total voting membership of the Association. Members of the Board of Directors and members of the Association not present in person or by proxy at the meeting at which the amendment is to be considered may express their approval (or disapproval) of the amendment in writing, provided that such approval is delivered to the Secretary of the Association prior to the commencement of the meeting."

Members of the Board of directors and members of the Association not present in person or by proxy at the meeting at which the amendment is to be considered may express their approval (or disapproval) of the amendment in writing, provided that such approval is delivered to the Secretary of the Association prior to the commencement of the meeting."
