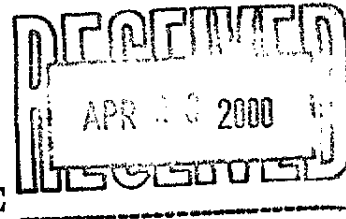

ARTICLE I

(Name)

(Board Approval)
