SIXTH: The name and address of the incorporator of this corporation is: MORDECHAI ARAZI, whose address is 109 Duval Street, Key West, FL 33040.


SEVENTH: This corporation shall indemnify its officers, directors, employees and agent to the full extent permitted by law.
