#### ARTICLES OF AMENDMENT

of

### St. Mary's Parish of St. John's Catholic Church, INC. A non profit corporation

The following articles were approved by the Members of St. Mary's Parish of St. John's Catholic Church on Sunday, March 12, 2000.

#### ARTICLE I.

#### NAME

Inc.

The name of this corporation shall be St. Mary's Parish of St. John's Catholic Church, and it is located at 6616 28<sup>th</sup> St. South, St. Petersburg, Pinellas County, Florida, or such other place as may be later established.

#### ARTICLE II

#### **PURPOSE**

The general purpose of this corporation is to build God's Kingdom on Earth and to take charge of and manage all the temporal affairs of said parish; to promote the spiritual, educational and other interests of said parish, including all charitable, benevolent eleemosynary work of said parish; to take charge of, hold and manage all property, personal and real, that may at any time or in any manner come to or vest in this corporation for any purpose whatever, whether by purchase, gift, grant, devise, or otherwise, and to do all other acts required subject to and in accordance with the by-laws and directives of the duly elected and appointed authorities of this parish.

#### ARTICLE III

#### **MEMBERSHIP**

The membership of this corporation shall consist of all those persons who desire to maintain membership in and abide by the rules or requirements of this parish. Only those people who actively participate in the life of the Parish both spiritually and financially shall be considered members in good standing.

#### ARTICLE IV

#### TERM OF EXISTENCE

The term for which this corporation shall exist shall be perpetual, unless otherwise dissolved according to the law. In that case all material possessions of the church will be distributed equally to all members in good standing with the parish, except for the living quarters of the pastor and all its furnishings which will revert to the pastor.
