- ONE:** The name and address of this principal corporation is Willie A. Battles Ministries, Inc., 2351 N.E. 200th Ave Williston, FL 32696. The corporation is organized pursuant to the Florida Nonprofit Corporation Code.
- TWO:** This corporation is a non-profit religious benefit corporation and is organized to spread the gospel of Jesus Christ. The corporation is organized under the Non-profit Religious Benefit Law for Religious purposes under GOD. To establish structured support service for Evangelistic Development and Other Ministries to support the outreach ministries for the body of Jesus Christ (The Church). In accordance with the Doctrine of the HOLY WORD creed/laws as a MINISTER to spread the gospel of Jesus Christ. The religious program will consist of Economic Development Programs, but, shall not be limited to: Homelessness, Health Care, Child Care, Youth At High Risk, Tutorial, Land Acquisition, Housing, Job Training, Counseling, Employment and other programs to aid those in need.

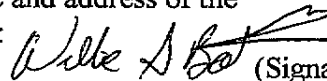
