ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is VOLCANIC STONE GRIILL CORP.

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on May 22, 2000.




