Article I

The name of the Corporation shall be Band Boosters of Boca Raton, Incorporated.

Article II

The street address of the initial principal office shall be 1073 W. Royal Palm Road, Boca Raton, Florida 33486 and the mailing address shall be P.O. Box 273852, Boca Raton, FL 33429.

Article III

The purpose of the corporation is to be a not for profit corporation under Chapter 617, Florida Statutes, and to promote and support the band program at Boca Raton High School through fund raising, transportation and any other activity that would enhance and foster the band program, its members and Boca Raton High School.

Article IV

The Corporation shall have a minimum of three and a maximum of fifteen members of the Board of Directors. The manner in which the members of the Board of Directors are elected or appointed shall be set forth in the Bylaws of the Corporation.


Article V
