ARTICLES OF AMENDMENT  
to  
ARTICLES OF INCORPORATION  
of

Pursuant to the provision of Chapter 617, Florida Statutes, the Undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation.

FIRST: Article VI is amended to read as follows: The business affairs of this corporation shall be managed by a sole director who shall be the S.E. District Superintendent of the national Church of the Christian and Missionary Alliance. Said Superintendent shall appoint all officers of the corporation. The Superintendent shall be guided by the "Guidelines for Developing Churches and by laws of The Christian and Missionary Alliance."

SECOND: The above amendment was approved by in excess of two-thirds (2/3) of the members of the corporation being sufficient for approval per the Articles and Bylaws of the corporation on the 28th day of February, 1999
