ARTICLES OF AMENDMENT  
TO THE ARTICLES OF INCORPORATION OF  
MILAM FUNERAL HOME, INC.

I. The following provisions of the Articles of Incorporation of MILAM FUNERAL HOME, INC., a Florida corporation, filed in Tallahassee on April 21, 1931, be and they hereby are amended in the following particulars:

Article III of the Articles of Incorporation be and it hereby is amended in its entirety to read as follows:

"The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 20,000 shares of common stock of the par value of fifty (\$.50) cents per share.

Stock may be paid for or given in exchange for cash, property, labor or services having a value, in the judgement of the Board of Directors of the corporation, at least equivalent to the full par value of the stock issued in payment thereof.

II. The foregoing amendment was adopted by the Board of Directors and the Stockholders of the corporation on the 16<sup>th</sup> day of December, 1999.
