

**ARTICLES OF INCORPORATION  
OF  
30-A PHARMACY, INC.**

**ARTICLE I**

**NAME**

The name of this Corporation is 30-A PHARMACY, INC.



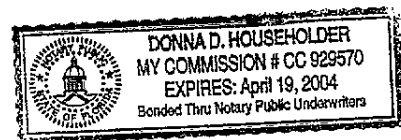
