This letter is to request an abatement of the penalty fees being imposed on my client due to a late filing of this form.

We believe there are mitigating circumstances that divert fault for the late filing from the corporation Hernando Skin & Cancer Center and place it on uncontrollable circumstances related to the transition from one accountant to another.
