

**ARTICLES OF AMENDMENT  
TO  
MAISON PACO RABANNE CONDOMINIUM ASSOCIATION, INC.  
NOW TO BE KNOWN AS 5900 COLLINS AVENUE  
CONDOMINIUM ASSOCIATION, INC.**

This First Amendment ("this Amendment") to the Articles of Incorporation of Maison Paco Rabanne Condominium Association, Inc. ("the Articles") is made as of this 22 day of July, 2000.

All capitalized terms used herein shall have the same meaning as in the Articles unless the context otherwise requires.

WHEREAS, the Articles were filed with the Department of State of Florida on July 10, 1998 and recorded on January 14, 1999 at Official Records Book 18437 at Page 596 of the Public Records of Miami-Dade County, Florida; and

WHEREAS, in accordance with the requirements of Florida law and Article XI of the Articles, the members desire to amend the provisions of the Articles in the manner set forth hereinbelow; and

WHEREAS, at a meeting of the membership on July 22, 2000 a sufficient percentage of the membership approved the amendment as set forth hereinbelow.

NOW THEREFORE, the Articles of Incorporation shall be amended effective upon recordation of this Amendment among the Public Records of Miami-Dade County, Florida as follows:

1. To change the name of the Association and to amend Article I and Article II of the Articles as follows:

**ARTICLE I**

**NAME**

The name of the corporation shall be ~~MAISON PACO RABANNE~~ 5900 COLLINS AVENUE CONDOMINIUM ASSOCIATION, INC. For convenience, the corporation shall be referred to in this instrument as the "Association", these Articles of Incorporation as the "Articles", and the By-Laws of the Association as the "By-Laws".

**ARTICLE II**

**PURPOSE**

The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act ("Act") for the operation of that certain condominium located in Dade County, Florida, and known as ~~MAISON PACO RABANNE~~ 5900 COLLINS AVENUE CONDOMINIUM, ("Condominium").
