
I am sending this letter to bring to your attention that some sort of error has occurred. Please see the copy of the cancelled checks and copy of the annual/uniform reports. The annual/uniform reports were sent to the state on April 14, 2000 for the following two corporations Educational Endeavors Incorporated P98000048280 and Global Discoveries Incorporated P98000047355.

However a letter was sent from the state saying that the report was not received until June 2000. As was discussed with Kathy at the 800 number, the cause for the delay in processing the applications could have been due to the processing center.
