ARTICLES OF INCORPORATION OF DISTRICT 21

VETERANS OF FOREIGN WARS OF THE UNITED STATES, INC

In accordance with the provisions of Chapter 617, Florida Statues, relating to corporations not for profit, the undersigned persons do hereby constitute themselves into a not-profit corporation and adopt the following Articles of Incorporation in accordance with said Statute.

ARTICLE 1 - NAME:

The name of his corporation shall be District 21 VETERANS OF FOREIGN WARS OF THE UNITED STATES, INC.

ARTICLE 2 - PURPOSE:

The general nature and purpose of the corporation shall be:

- (a) Fraternal, patriotic, historical and educational; to preserve and strengthen comradeship among its members; to assist worthy comrades; to perpetuate the memory and history of our dead and to assist their widows and orphans, to maintain allegiance and fidelity to the Constitution of the United States and of the Veterans of Foreign Wars of the United States and its By-Laws; to foster true patriotism; to maintain and extend the institutions of American freedom; to deserve and defend the United States from all her enemies, whomsoever.
- (b) To take by gift, devise, purchase or in any manner, whatsoever, real and personal property, and to sell, transfer, lease or rent in any matter whatsoever, the same, and to do all things necessary and essential thereto for the benefit of the corporation.
- (c) To do all things necessary and essential to carry on the activities, rehabilitation, welfare and social work of the District.
- (d) The said District 21, VETERANS OF FOREIGN WARS OF THE UNITED STATES, INC., shall at all times remain under the jurisdiction of, and be governed according to the Constitution, By-Laws and Manual of Procedure of the Veterans of Foreign Wars of the United States. In the event that any provisions of these Articles of Incorporation conflicts with the National Charter and By-Laws of the Veterans of Foreign Wars of the United States, such conflicting provisions shall be deemed null and void, the National Charter and By-Laws, at all times, govern.

ARTICLE III - MEMBERSHIP:

Any person who has served honorably as an officer or enlisted person on active duty, honorably discharged, releases to inactive duty or returned, shall be eligible for membership.

- (1) Whose service in the armed forces of the United States in any foreign war, insurrection or expedition is recognized as campaign medal service and governed by the authorization of the issuance of a campaign badge (medal) by the Government of the United States of America, and
- (2) Who is a citizen of the United States.
- (3) The active and voting measure of his corporation shall act all times be confined to the active membership in good standing in District 21, Veterans of Foreign Wars of the United States, Inc. with eligibility to, acquiring of, suspension from, and discontinuance of membership being in accordance with the National Constitution and By-Laws of the Veterans of Foreign Wars of the United States.



ARTICLE IV - TERM:

This corporation shall have a perpetual existence, subject to the laws and provisions of the State of Florida and the Constitution and By-Laws of the Veterans of Foreign Wars of the United States.

ARTICLE VI - MANAGEMENT & ELECTIONS:

The Board of Directors shall managed the affairs of this Corporation and shall consist of the District Commander, the District Sr. Vice Commander, the District Jr. Vice Commander and the District Quartermaster, and they shall be elected at a regular meeting to be held during the month of May each and every year. Actions of the Board of Directors as set forth herein shall be at all times subject to the approval of District 21.

The above Directors shall serve until the next election of District Officers during the month of May of each and every year and who by virtue of their office serve as Directors of the corporation.

ARTICLE IX - BY-LAWS:

By-Laws for this corporation may be made, altered, or rescinded after presentation to the District by any member in good standing and approved by a two-thirds (2/3) vote of the District membership present in good standing at a noticed meeting. However, said By-Laws shall not conflict with National Charter, Constitution, By-Laws and Manual of Procedure of the Veterans of Foreign Wars of the United States, nor shall they conflict with the By-Laws of the Department having jurisdiction and provide a copy of same shall be forwarded, through channels, and reviewed by the Commander-in Chief before becoming effective.

ARTICLE X - AMENDMENTS TO ARTICLES OF INCORPORATION:

Amendments to these Articles of Incorporation may be made after presentation to the District by any member in good standing and approve by a two-thirds (2/3) vote of the District membership present an in good standing at a noticed being. However, said Amendments to the Article of Incorporation shall be in accordance with the Laws of the State of Florida, and in accordance with the National Charter, Constitution, By-Laws and Manual of Procedure of the Veterans of Foreign Wars of the United States, and further, they shall be in accordance with the Department having jurisdiction and provided a copy of same shall be forwarded, through channels, and reviewed by the Commander-in-Chief before becoming effective.

ARTICLE XI - MISCELLANEOUS:

In the event of a dissolution of this corporation all of the assets shall be the property of District 21, Veterans of Foreign Wars of the United States, Inc. and in the event vote of the simultaneous dissolution of this corporation and the forfeiture of the charter issued by the Veterans of Foreign Wars of the United States to said subordinate unit, then, and in the event, title to all of the assets of this corporation shall pass to the Veterans of Foreign Wars of the United States to be disposed of in accordance with the National By-Laws, Rules and Regulations of the said Veterans of Foreign Wars of the United States. At no time shall the assets of the corporation be distributed among the individual member thereof.
