FIRST: Amendment adopted:

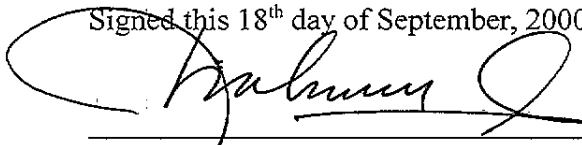
Article I is hereby amended to read as follows: The name of the corporation shall be: MAYATRADE INVESTMENTS CORPORATION.
