# ARTICLES OF INCORPORATION OF SWISKA ENTERPRISES, INC.



#### <u> Article I - Name</u>

The name of this corporation is SWISKA ENTERPRISES, INC. and its principal office is located at 6300 N. Wickham Road, Suite 130, Melbourne, Florida 32940.

### **Article II - Duration**

This corporation shall exist perpetually. The date of commencement of corporate existence shall be the date these articles are filed with the Secretary of State.

### Article III - Purpose
